Submission of Dossiers proposals: 2024 and 2025 editions

The *Outros Tempos* Journal, from the History Course of Maranhão State University (UEMA), publishes the call nº 11/2022, to select proposals for thematic dossiers to be published in volume 21, issue 38 (2024.2), volume 22, issue 39 (2025.1) and issue 40 (2025.2).

A Proposals must be sent to the email [outrostempos\\_revista@yahoo.com.br](mailto:outrostempos_revista@yahoo.com.br) ~~until October 31, 2022,~~ **until November 15, 2022**, indicating as subject: **Dossier Proposal**.

The proposal must be prepared by two or three organizers, obligatorily doctors and from different teaching or research institutions, containing the following items:

- dossier title;
- names of the dossier organizers, with a link to CV Lattes (or equivalent, in the case of foreign researchers and/or linked to HEIs based in another country);
- summary of the dossier topic (from 15 to 20 lines).

Note: Proposals in which one of the organizers is linked to a teaching or research institution based outside the country would be a plus.

Organizers must sign a Term of Commitment (see ANNEX I), in which they declare that they are aware of this Call rules and also the Journal rules and undertake compliance to them. The terms of commitment must be submitted completed and signed, together with the proposal.

The Editorial Board of *Outros Tempos* will analyze the received proposals, with the prerogative of selecting them and defining to which volume and issue each proposal will be sent. Results will be announced by **November 30, 2022**.

Dossier organizers must commit to forwarding them to the Journal's e-mail, within the same deadlines established for sending articles to the aforementioned Dossier:

- 01 (one) interview;
- 01 (one) case study, and;
- 02 (two) reviews, which will also be part of the Dossier.

The reviewers who will evaluate the articles sent to the Dossier will be defined by the organizers, in partnership with the Editorial Board of *Outros Tempos* Journal. The number of articles that will compose the dossiers will be defined by mutual agreement, and must not exceed the number of 10 (ten).
